

Copyright Notice Policy

Whereas Bitkub Moonshot Co., Ltd. (the "**Company**") places significant importance on the protection of creative works subject to copyright, the Company hereby announces this Copyright Infringement Notice Policy (Copyright Notice Policy) to safeguard and protect the rights of copyright owners and to serve as a guideline for action against Users who infringe upon copyright, with the following details:

1. Submission of Copyright Infringement Notice

1.1 In the event that a User who is a copyright owner possesses reasonable evidence to believe that another User has infringed its copyright on the Company's Website, the copyright owner may submit a notification to the Company requesting the suspension of the computer data constituting the copyright infringement. This notification shall be provided in writing using the form prescribed by the Company, or submitted electronically through the designated complaint channel (the "**Notice**") describing with following details:

- (1) The full name or corporate name, address, telephone number, and email address of the copyright owner that the Company is able to contact the copyright owner.
- (2) The copyrighted work claimed to have been infringed and the evidence establishing ownership of the copyrighted work.
- (3) The computer data claimed to be infringing and the location or source of that computer data.
- (4) An affirmation that the information provided in the notification is true and accurate.
- (5) The physical or electronic signature of the copyright owner

1.2 Upon the Company's receipt of the Notice from the copyright owner pursuant to Clause 1.1, the Company shall, without delay, proceed to suspend access to the computer data claimed to be infringing on the Company's Website. Concurrently, the Company shall notify the User accused of copyright infringement to provide the accused User with the opportunity to file a counter-notice or contest the rights thereafter.

1.3 The User who is the copyright owner represents and warrants that, prior to submitting the Notice to the Company pursuant to Clause 1.1, the User who is the copyright owner has carefully and thoroughly considered all exceptions of the copyright infringement, and all details described in the Notice, including any evidence and statements provided to the Company, are true and accurate in all respects.

2. Contesting to the Copyright Infringement Notice

2.1 The User accused of copyright infringement has the right to contest the Notice submitted by the copyright owner by providing a written document using the form prescribed by the Company, or submitted electronically through the designated complaint channel (the "**Counter-Notice**") that describe the following details:

- (1) The full name or corporate name, address, telephone number, and email address that the Company is able to contact the User accused of copyright infringement.

- (2) The computer data for which access has been suspended, and the location or source of that computer data prior to the suspension of access.
- (3) A statement declaring that the suspension of access to the computer data was made as a result of mistake or misidentification; and
- (4) The physical or electronic signature of the User accused of copyright infringement.

In the event the User who is the copyright owner fails to provide complete information or omits any information referenced above, the notification shall not be deemed to have informed the Company of the copyright infringement.

- 2.2 Upon the Company's receipt of the complete Counter-Notice, including all details from the User accused of copyright infringement pursuant to Clauses 2.1 (1) to (4), the Company shall promptly forward a copy of the Counter-Notice to the copyright owner. Concurrently, the Company shall notify the copyright owner that the suspension of access to the relevant computer data will be terminated upon the expiration of thirty (30) days commencing from the date the Company received the Counter-Notice.

The Company shall terminate the suspension of access to such computer data within fifteen (15) days commencing from the date of the expiration of the thirty (30) days period specified in the first paragraph, provided that the Company shall receive no notification, along with evidence, from the copyright owner indicating that the copyright owner has filed a lawsuit with a court of competent jurisdiction against the User. In such an event, the Company reserves the right to continue the suspension of access to the computer data until the Company receives conclusive evidence that the litigation between the copyright owner and the User accused of copyright infringement has been concluded.

- 2.3 The User accused of copyright infringement represents and warrants that all details describe in the Counter-Notice, including any evidence and statements provided to the Company, are true and accurate in all respects.

3. Repeated Copyright Infringement

In the event that the Company receives the Notice from a User who is the copyright owner concerning copyright infringement by any User more than three (3) times, and there is reasonable ground to believe that such User has committed repeated copyright infringement, the Company reserves the right to immediately suspend the use of that User's account or suspend the User's access to the Website without any prior notice.
